One of the rarest things in Vaishnavite tradition is to see Lord Vishnu represented without his serpent Adishesha giving him a roof, the conch, the chakram or the celestial discus, and the mace. But there is one temple in Mamallapuram, where this deity is worshipped as 'Sthalasayana Perumal', found lying on bare land, without any of his usual grandeur, and sharing

the deity with his consort Mahalakshmi as 'Nilamangai Thayaar'.

The Sthalasayana Perumal temple, located about 45km from Chennai, was built during the Vijayanagara period in the 14th century AD.

It stands amid the ancient seashore temples carved during the earlier Pallava dynasty, and along with 32 other seashore monuments, has been declared a world heritage site. It is maintained and administered by the state's HR & CE

Department.

As renovation work is completed the 'Mahakumbabishekam' of Sthalasayana Perumal temple will be held on February 1, 2024. The temple authorities is making arrangements for the kumbabishekam. The RDO Narayanasarma conducted review of arrangements. He also chaired the consultation meeting with temple authorities. Mamallapuram DSP Jagadeeswaran, Inspector Magala prabha, others were present at the review meeting. They

discussed about security arrangements, Transport, medical facilities, annadhanam, Chief guests attendance.
